Money:

- To give the Eco Rep £100 to buy an assortment of environmentally friendly stationery, which JCR members can then buy at cost from them, at around these prices
- To mandate the JCR president, JCR president-elect, and JCR treasurer to buy an appropriate, if purely symbolic, present on behalf of the JCR, up to the sum of £200, in recognition of his work for the college and the JCR

- Make a pro-rata loan of £300 to Flipping the Bird Productions to help finance the upfront costs of the show; to see the show at least once to have your mind blown, and ensure the JCR gets its money back, and to petition the governing body to make Tom Barker a fellow of the college.
- To give the Entz team £150 to make the bop as awesometastic as possible, with any unspent money being given back to the JCR
- To donate £500 to the Corpus Ball
- To donate £150 to the staff Christmas party; and to mandate the JCR President to attend the party and report back to the JCR on what happened, with photos
- To subsidise the committee handover dinner by £5 per person as an incentive and thankyou

Preliminary Business

- Ball update from Alex Harmer: all going well; tickets selling fast so if you want one get one quick! You can now buy these online. They have given a Report on the progress to Governing Body. Next term they'll be putting up lots of info about what food and drink etc there will be, stay posted...
- Ed Brown (OUSU rep) gives a low-down on the referendum on being affiliated to OUSU that's happening later on in 8th week – it's constitutional that we have one every year. Affiliation costs = £1600 (this is proportional to the number of students in our JCR). Pros of being affiliated: we get online election software (which costs ~£1750) for free; lots of welfare support and advice, and stuff like free/discounted condoms etc; we get 3 votes on OUSU council, which is good to get involved in to have a say in how we as Oxford University students are represented both to the University Higher powers and to the wider world. Whether we're affiliated or not, OUSU have to give us a certain amount of stuff just because they are an SU and they have to (not including the aforementioned stuff); we could disaffiliate and 'free-ride', but if every college did that OUSU wouldn't be able to do all the great stuff it does. Ed recommends voting to stay affiliated. When asked, Tom B adds that OUSU affiliation costs make up 6% of the total JCR budget.
- Ben reads his poem. It gets a hearty applause. [Secretary notes: It was epic. You should have been there.]

1. Sleepy time... Mugs and blankets

Stephan Ambrose asks how many people like to sleep in the JCR? Quite a few hands go up. Matt Ryder suggests that the Big TV room is a good place to sleep; much warmer than the JCR. Nikki Hutchison informs everyone that she learnt recently you turn on the small fire by pressing the big red button. Everyone else seems to already know this however.

Lisa Blundell asks who will wash the blankets? Stuart admits he hasn't thought this through.

AMMENDMENT: Stuart scraps the blankets.

There is some discussion on the practicalities of having larger cups, as they mean the JCR officers running tea will have to run back and forward making much more tea to fit in the bigger mugs, and the kitchen staff might not be able to wash and store them for us [Secretary notes: technically, the mugs we use for JCR Tea belong to the Buttery], as they do now. James Pontifex eventually suggests instead of buying bigger mugs, asking the buttery to procure bigger mugs? This accepted as friendly.

4. We need a TV!

The JCR Notes :

SFQs

James P clarifies that he may soon have a TV he will be able to sell – discounted – to the JCR, but before this he wanted the JCR to decide on a system to keep it safe, so that when they bring to a meeting the idea of buying his TV for the JCR, no one will object on grounds like 'What if the TV just get's trashed?' The TV in mind is apparently a Phillips home entertainment sort, with surround sound.

Katie Bayliss asks what happens if you sign out the key to watch something, and then someone else comes in at the end and wants to watch something else. It's a faff to have to take it back to the lodge and sign it over.

James P replies that it isn't that much of a hassle to walk the short distance to the lodge, and this is a better system than the one currently in place.

Hannah Buxton suggests a proximity card system like the ones currently in use throughout college; that way we'd know who was in there when/if the TV got trashed. General enthusiasm for this idea, but dubiousness about the cost. Security cameras, and a lockable TV cabinet are also suggested. Ben Fell suggests investigating the costs of a proximity card reader being installed. Leanne proposes this as an amendment; accepted as friendly.

Anna Pick points out that if the TV room is locked, it will make it awkward to use the other JCR computer that is up there. James P says this could be moved to the small TV room.

5. Changing the Access and Admissions Officer's Job

This JCR notes:

1. That the standing orders for the A&A Officer were changed last week, to the following:

- i. To organise Open Days, liaising with the admissions office and the subject reps.
- ii. To organise the college families system, including welcoming freshers on their day of arrival, introducing them to their college parents, and coordinating events for families.
- iii. To liaise with the JCR member responsible for the JCR website to update the Admissions section of the JCR website, including details of subject reps and dates of open days/interviews.
- iv. To liaise with OUSU on matters relating to access schemes and admissions and keep the JCR informed accordingly.
- v. To take school groups for talks and tours if and when required by the admissions office.
- vi. To keep the prospectus up to date, coordinating with the admissions office and tutor for admissions to do so.
- vii. To keep informed about access schemes running in Oxford, investigate them and encourage participation from the JCR where appropriate
- viii. To help organise and run interviews, including staying up in Oxford for the duration of the interview period, and coordinating the activities of the subject reps.

2. That on Wednesday there was a meeting between Laura Lee-Rodgers (current A&A officer), Preeti Dhillon (JCR pres), John Watts (senior tutor) and Jeni Clack (A&A administrator) to sort out the confusing overlap and differences between the roles of subject reps and JCR A&A officer.
3. That interviews and open days take up a lot of time during the holiday, and that subject reps are currently paid to attend them, whereas the A&A officer is expected to lead them, but is not paid.

This JCR resolves:

1. To amend the standing orders of the JCR A&A officer in the following way:

Point i to be changed to:

To brief the subject reps about open days, mainly focussing on the main strategies for 'selling' Corpus, and to seek feedback from subject reps about the open day, and how the attendees responded.

Point viii to be changed to:

To liaise with the subject reps about ideas for interview season, and to seek feedback from the reps afterwards.

2. To mandate A&A officer to put together a 'handover guide' for subject reps and A&A officer to ensure a smooth transition to the new system.

For this year's interviews she will be doing this' this would be starting next year.

This JCR resolves:

1. To mandate the JCR president, JCR president-elect, and JCR treasurer to buy an appropriate, if purely symbolic, present on behalf of the JCR, up to the sum of £200, in recognition of his work for the college and the JCR.

Alice Jones asks when it would be presented? Preeti D says she's in conversation with the President's secretary; they're going to invite him to a JCR tea.

- A corpuscle is the producer for the show and therefore responsible for financing it.
- Corpus has a good record of supporting projects in the arts (we gave a fellowship to the guy that financed the theatre...

This JCR believes that:

- Ambitious artistic projects are an important part of university life.
- Supporting artistic projects is a culturally enlightened way of using JCR funds.

This JCR resolves to:

- Make a pro-rata loan of £300 to Flipping the Bird Productions to help finance the upfront costs of the show.
- Go to see the show at least once to have your mind blown, and ensure the JCR gets its money back...
- (Conditional on resolve 1 being passed) To petition the governing body to make Tom Barker a fellow of the college.

SFQs

Seb B asks who will do the petitioning? James says Tom Barker will.

Alice (?) asks what the effect will be in JCR Funds. Tom B explains that there is an arts budget, paid for by the Arts Levy, every term, and we haven't spent all this yet this term, so the loan will come from here. [He also explains a pro-rate loan; see Wikipedia for details.]

Lisa B asks what proportion of the productions overall budget is £300? Jeremy replies not much. Tom asks if they will get their money back? Jeremy says that they should do, but as always it's dependant on ticket sales.

However, they only need to sell 42% of their tickets to break even, which is pretty good. The production team are new, but made up of members who have produced profit making shows of a similar genre before.
