- to donate £375, £330 to help cover the start-up costs and first outing of Corpus Golf Society, On condition that the society is open to all Corpus students for a lifetime membership for £10 or £5 annual membership and that all members have equal rights
- To mandate the new Corpus Golf Society to make the two people holding membership to be the President and Treasurer, and continue this on annual basis and they are responsible

Matt: Where is golf course?

George: Southfield, all travel cost funded by own people (not JCR)

Naomi: What would you get from membership?

George: Can use golf club at 5 days

James: Corpus Golf Soc will provide equipment

Francis: When we've paid £5 we can borrow your (James) clubs whenever?

James: Um, yes

Katie: Which 5 days?

George: Monday to Friday, but maybe pay more for weekends

Naomi: James, we can afford this?

James: Yes, definitely.

- Freshers Week could do with a separate and more formalised budget

- To create a Freshers Week Committee (the ENTZ team)
- To mandate the ENTZ team to appoint a Freshers Week Committee President
- To approve the following standing orders for the Freshers Week Committee President

***Motion Twelve: Clubs and Socs Stuff***

This JCR Notes:

- The Clubs and Societies Officer has been lax in carrying out his second standing order
- The Challenge could have been better organised
- The Challenge should continue to include a formal hall for around £6.00

This JCR Believes:

- The Challenge requires a lot of organisation and the Clubs & Socs Officer's responsibility for organising extras such as t-shirts, transport and formal should be formalised
- The college should contribute to an integral part of the JCR calendar including ridiculous Cambridge hall costs

This JCR Resolves:

- To create standing order v) "to clear and/or recycle all Careers publications from the JCR at the end of each term"

### ***Motion Fourteen: Conference Guests and JCR***

#### This JCR Notes:

- The JCR has to be emptied for conference guests at the end of each term

- The College's primary concern should be its students
- Conference guests would not mind a tidy JCR with posters (what do they expect of an Oxford JCR ?)
- There are many other rooms that conference guests could use as a common room
- Many prospective students visit the college over the vacation and are met by a dull, undecorated room

This JCR Resolves:

- To mandate the JCR president to communicate these views to the College authorities
- To mandate the JCR president to investigate a) purchasing the JCR and renting it back to College over the vacations or b) to request a small financial compensation from the College each time the Junior Common Room is required to vacate its Common Room
- To mandate the Returning Officer to add these views to the Policy Document

***Motion Fifteen: Conference Guests and Rooms***

This JCR Notes:

- That many JCR rooms have to be emptied for conference guests at the end of each term
- Finalists are particularly vulnerable to these orders
- The College make a lot money from conferences
- The College depends on exam results to a large extent for its reputation

This JCR Believes:

- The College should be run in the interests of its students, not merely financial gain (there should be a recognition that while related these two factors are not incompatible or of equal merit)
- That finalists staying up for the Easter vacation deserve to stay in their own rooms if they are paying for vac res
- Conference guests could be accommodated in Magpie Lane, Kybald and New Building

This JCR Resolves:

- To mandate the JCR president to communicate these views to the College authorities
- To mandate the JCR president to investigate a) the possibility of finalists being allowed to stay in their rooms over the Easter vacation before their exams or b) to request a financial reimbursement be made to those finalists forced to vacate their rooms over this period in recognition of the disruption caused in moving and the financial gain achieved by the college in replacing their own JCR members with guests from outside the University.

- To mandate the Returning Officer to add these views to the Policy Document

### **Affiliations**

This JCR is affiliated to OUSU

## **Policies**

### **Fairtrade**

- This JCR supports the Fairtrade system of certification (as propagated by the Fairtrade Labelling Organizations International) is worth supporting.
- Wherever reasonably possible, the JCR should purchase fairly traded products, rather than non-fairly traded alternatives. (02/05/2010)

### **Socially Responsible Investment**

- The JCR supports OUSU's Socially Responsible Investment Campaign (SRI). It believes that the college should be open about its investment policy and portfolio. The JCR therefore calls for full transparency, and institutionalisation of rights to transparency in order to ensure accountability in the future. (02/05/2010)

### **Equal Opportunities**

- This JCR is committed to equality for all students regardless of socio-economic status, religion, ethnicity, gender or sexual orientation.
- This policy relates to JCR activity, as well as college's conduct towards its students and applicants. (02/05/2010)
- This JCR supports the idea of having a female tutor in every interview

### **Access**

- This JCR commends the work that is being done by College to promote equal access to Corpus.
- This JCR is committed to helping College in its efforts to broaden access, and, where possible, to undertake its own independent access work. (02/05/2010)

### **Representation within college**

This JCR believes that student input should be permitted and encouraged in all areas of college decision-making. This includes the beliefs that:

- Representatives of the JCR should be able to bring motions to Governing Body
