- Over the past fortnight I've:
 - Redecorated the JCR.

4. Tuition fees

This JCR Notes:

1. The House of Commons vote on the 9th December 2010 and the House of Lords vote

on 14th December 2010 to raise the cap on Home/EU undergraduate tuition fees to £9000.

2. That the University of Oxford will at the 9th week University Council of Hillary term 2011 set an undergraduate Home/EU fee level for the 2012/13 year.
3. That because of the concurrent cuts to Government funding for Undergraduate Teaching, all Universities will need to charge approximately £7200 p/a in order to maintain the status quo of teaching funding.
4. That the University estimates that it costs £16,000 p/a to teach the average undergraduate student.
5. That the University as a whole is not operating a structural deficit, but that it is unable in its current financial situation to make the necessary investment in order to compete with the top Universities worldwide.
6. The current recalibration of the Oxford Thinking Campaign, which has recently passed its original target of raising £1.25 billion.

This JCR Believes:

- 1) That the Government's reforms are likely to exercise a significant deterrent effect on school students from low-income backgrounds applying to Oxford.
- 2) That Oxford University should take radical steps to try to redress this deterrent effect and to promote the widening access agenda under the new funding arrangements.
- 3) That charging less than the £9000 maximum for Home/EU undergraduates will make a real difference to the image of Oxford in the public view and the ability of the University to attract students from low-income backgrounds.
- 4) That even if the University were to charge £9000, this would not represent a long-term solution to the University's inability to compete on a world-level in terms of investment in teaching and resources.
- 5) That fee wavers for students from the lowest income families have the potential to attract talented individuals who would otherwise be deterred by the level of student loan debt.
- 6) That the recalibrated Oxford Thinking Campaign should focus heavily on widening participation in the new national funding context.
- 7) That all Oxford undergraduate courses should have the same fee level for Home/EU students.

This JCR Resolves:

- 1) To mandate the OUSU Executive to lobby the University to set a fee level significantly below £9000 for Home/EU undergraduate students for the year 2012/13.
- 2) To mandate the OUSU Executive to lobby the University to establish fee wavers for students from the lowest income backgrounds, such that for school students who are eligible for free school meals at least one year of their Oxford tuition will be free.

- **Chair ceded to Donal O'Hara for duration of motion**

- Jack summarises:
 - Higher Education Bill passed in Parliament so can now charge up to £9000 – Oxford seen as one of the unis that will charge full whack
 - Motion mandates OUSU to push uni to lower limit to £5,2000? – the amount it needs to be to break even.
 - At the moment uni has a structural deficit – OUSU says could be cuts, and more reliance on Oxford THining Campaign
- Questions
- Taff- future of OOB?
- Jack – Bursary will be expanded, currently in process of review
- Nick – OUSU pushing for cuts in teaching budget rather than increasing tuition fees?
- Jack – point of motion is to get feel, that's one of the motions put forward by OUSU; also, degrees being charged at different rates so that humanities are charged £9000 while science are £7,200
- Debate
- Gareth – thinks we need to think about science versus humanities, should be a set price across university; especially as science costs more
- Felix- OUSU says difference in cost of science degree is difference in cost of budget?
- Taff – Scientists can cause a lot of cost depending on what they break easily £200 or £300 while dropping glass, a historian drops a book that's no problem
- Colette – points out that some of the pottery she handles is worth half a million. If that gets dropped, it's expensive.
- Taff- and how often does that happen?
- Colette – twice.
- Filipe – in order not to discriminate, why not charge everyone £8,100 as that's the average
- Jack – set price is what everyone wants?
- *yup*
- Taff – mentioned at NUS the other night, need to make sure that ask how student loans company will be reformed in current structure.; especially as people will go from Scotland to England and vice versa, and Wales etc. Uni has to lobby in right places
