Motion 3: Welfare football

This JCR Notes: Welfare football

- Welfare football is becoming increasingly popular, as can be judged from the frequent welfare football e-mails (often disguised by some other title eg. a proposal for the uncoordinated).
- Using shoes/wallets/jumpers as posts is not very practical.
- Having to run and fetch your shot wastes time/energy.
- Scoring a goal should not be seen as a negative thing.
- That the college football teams do not have anywhere to train in the summer.

This JCR Believes:

- That welfare football is good for you (physical exercise/extracurricular activity/social bonding).
- That 5-a-side goals would encourage people to attend welfare football.
- That poor performances on the pitch can be attributed to a lack of cohesion in our football team, which can in turn be attributed to a lack of quality training.
- That there is ample space at our sportsground in the summer to set up a 5-a-side pitch alongside the cricket field.
- That good quality, portable goals can be bought at a reasonable price.
- That a number of people would be interested in a 5-a-side tournament in the summer.
- That, since this is a welfare/clubs & socs issue, we can come to some compromise on the purchase of goals.

Debate

- Gareth – considering already passed motion to support academics in current pensions crisis, we should pass this as well.
- Jack – says something about how this motion as a JCR transcends all HE discussions we’ve had before. [*JCR looks at him slightly bemused.*]
- Joe – is that in the record?
- Donal – can we strike that from the record?
- Greg – what do we have to do to ‘lobby’?

Rent

- The SCR Rent proposal is 4.18%.
- This proposal is Van Noorden.
- CPI is 4.5%
- RPI is 5.2
- Student loans are being frozen in the 2011/12 academic year

The JCR President proposes accepting this offer, but negotiating to include fringe benefits to members eg. On the sportsground issue.

Discuss.

Jack – nice discussion, we're not going to pass anything.

[Greg makes announcement: The Prestige on at 8.45pm for Corpus Cinema this evening.]

SCR rent proposal is 4.18%. Been difficult year for UK economy – sluggish growth, high interest rates.

Lots of rent increases - Exeter are 12%; St John's are going for 2% after three years at 0.3% - anarchy

SCR said that without bursar, will stick to Van Noorden – 4.18 – 4.48. SCR gone for lower end of Van Noorden. Considering everything, not the worst rent proposal in the world. But have to take into account that student loans frozen next year.

Felix Neate – that sounds reasonable, proposing accepting but negotiating extra benefits. Can't say accept if you want extra, should say you want such and such.

Jack – Corpus never actually submitted rent proposal until last year, want to keep that up but be reasonable and get benefits like using JCR during Easter vac. Green Action plan: energy costs we save redistributed in JCR

Gareth – fringe benefits, also need to hit hard on standard of accommodation. Things like microwaves and freezers are standard in every other rental market, should be getting those as well. Should be getting median standard for median price.

[Mike's phone goes off with chirpy sound. Apologises to Gareth].

Jack – top secret proposals, will be announced later.

Greg – can we not have it as given that increasing rent is standard when college has millions; when academics getting all this free stuff. SCR gets free coffee and biscuits, can we not start with that?

Colette – worried that people at telethon make us loads of money, massively successful this year and beat almost every other college (Well done, Mek in the corner). We make them so much money, why do then need to always have that rent increase.

Greg – can we withdraw service?

Jack – that’s the Apocalypse Option. This is quite nice, don’t want to screw over my successor.

JW – we’re already being screwed over, like internationals don’t get any storage room at all.

Dellar – go for zero, or even less.

George Simms – to what extent do former members of college pay attention to stuff like this? What extent does rent depend on quality of the room?

Jack – old members do take interest; last year, Miliband recorded video for us. And if they squeeze money out of us now, we’re not going to want to give it back later. Used to be really low rent, then when Liddell came up it went up 30%.

Mike – and that’s stupid, it’s all geographical for grade of rooms; I was charged A last year just because I was in Magpie, when my room wasn’t all that great, had mould.

Sam – energy increase because of increased costs, or because we’re more energy inefficient?

Jack – mainly costs.

Felix – not entirely unreasonable that would move mould.

Jack – you are meant to contact us if there is mould....

Gareth – harking back to why don’t SCR contribute to perks, if look at average, Oxford academic paid a lot below what would get elsewhere. Secondly, we need a much better grading system. In Balliol there’s six of seven different categories so wide range.

Jack – that would need to be a JCR motion.

Gareth – but we should sort that out and send a proposal.

Dellar – know college want to put up rent but there’s loads we can do to screw them over

JW – set the college on fire...

Dellar – can we undermine them on telethon, get alumni to pay for us?

Mek – we can't call alumni, college sends them a letter.

Dellar – we can get the alumni. They would help us.

Jack – next year when they put rent up by 10%, then we can go nuclear.

Della – but if we do hardline now, we can make them reconsider trying to put rent up again next year.

Greg – if we get 4.18% we're not going to get 4.18% increase in service, we all know that. It's not even a question of who would win if we all say "we're not going to pay that", they can't throw us all out. If end comes to end, we can stop this. We're the main sort of income

Sophie – 40% of income actually comes from conferences [*Secretary notes: I got this figure wrong – it's actually 11%*]

JW – when are we going to discuss this, can someone come with you? We know you want to keep things amenable (and Greg if you go in, it won't stay like that, with all due respect). Are we only allowed to send one person?

Jack – technically, yeah.

Dellar – they should be coming to us.

Jack – I can arrange a meeting.

Felix – perhaps we should be more moderate now, rather than going completely extreme now; then where do we go next year if they put it up loads.

Alex – fair point, but reason not getting hit with higher point now is we don't have a bursar right now. So if we did have a bursar, then would possibly have a larger increase next year, This is the year to be moderate.

Jack – bit of a thing when I talked to Colin Holmes that Bursar is dead.

Felix – that's their problem, not ours.

Dan – what was increase last year?

Jack – 5%, then to median (which turned out to be same). This is the lowest increase in three years.

Gareth – we negotiated them down last year without going crazy.

Dellar – still need to be aware that we can do more.

Gareth – college can do more, can refuse to give degree.

Jacl – I don't know how united JCR is on this point.

Gareth – maintenance support

Colette – can't do anything academically, that's separate to accommodation fees. Secondly, how are we in relation to other colleges in last several years.

Jack – we've gone from bottom two, to median.

Greg – I have to leave, but not doing a Jeremy Lloyd.

Felipe – I'm not even a British citizen and I'm charged the same as any of you, I'm very grateful and don't find it ethical to ask them to pay less. I wouldn't support this.

Mike – In terms of 'going nuclear' and extreme v moderate; when they say Bursar is dead. I'm in support of hardcore action if Bursar in place; but there isn't, they can't handle any other sort of calculations, so there's no sense in going crazy and trying to change rent. It's just a waste of our trump card, there's no scope for change. Save this for next year.

Mek – College are proposing we stay at median level, going up at lower Van Noorden. Do we have any evidence about quality of accommodation where Corpus lies on the scale. Without clear evidence that we are below the median on quality while paying the median, there's no way that JCR is going to be united. We need evidence for why this is really unjustified.

Dellar – our rent increase is one of the highest over the last few years.

Jack – current plan is to remain at median, then it will go up when New New Building is built.

Mek – does anyone of idea how good our accommodation is.

Colette – Can we ask them to put into position what happens when something happens where Bursar can't fulfil position that there is a proxy Bursar.

Jack – Colin Holmes.

Colette – obviously not good enough.

George – Can you negotiate long term changes in price? *General feeling is that there is a sentiment that we are discussing rent increases way in advance.* More sensible to wait until new Bursar?

Gareht - when we had deflation, rent still went up.

Jck – that was when chasing median, now we are at median. Where do we go from here. Do we want to reject this proposal?

General room:.....no....not worth it now, leave it for next year. Express reservations that have been raised; like that we're not being treated seriously.

Want to instill idea of debate.

Jack: we'll come up with a JCR proposal and bring it up in 6th week meeting where we can vote on it. General room thinks yes.

Colette – we want to look into quality, that should be reflected by price.

Jack – OUSU should be looking at quality across colleges.

Colette – 80% of our rooms, in my opinion, are at lower standard. Eg painted more, better showers etc.

Mek – are we running on a profit in college?

[Secretary notes: college has been running in a deficit for the last few years, and this is projected to continue until 2014/15]

Secretary – points out roof costs, almost half a million pounds unexpected costs, plus have discovered more issues that need resolving.

Dellar – unnecessary costs, eg my scout comes every day. We should choose our own perks.

Jack – this has been very productive, thank you.
