Points for debate:

Gareth – we used to subscribe to *Private Eye* and then stopped because people kept removing it from JCR and reading it for themselves. So we would need people to be respectful.

Greg Yates– are we going to set any kind of limit on how many different magazines we are going to include?

Nick Dickinson – limit is democratic, if people don't want it, don't vote for it.

Mek Mesfin – do we have a budget.

Donal O'Hara – in Pontifex era there were plans to greatly expand newspaper and magazine budget but eventually got scrapped as would cost too much.

Mike – important to remember that not tied in; we pay for a year, and can then review later. Can avoid bloodsport debates taking place. Mandate him to do a yearly review?

Hannah – order form had two days notice, so we ordered before knowing if JCR would pay

### Short factual questions

Gareth – why have you proposed and seconded without approval of cricket captain or Vice Captain?

Donal – I don't need the approval of anyone; James told me he had emailed you but yet to receive a response

Gareth – because we were about to say it's a stupid idea

Jack – let's not be passive aggressive.

George – what's this got to do with Pontifex?

Hannah – there's history....

Greg – if buy more expensive cricket bat, what's the increase in game play? Is there a cost/benefit?

Donal – I imagine there is. James became intrigued after reading an article about them, which differ from traditional bats. He felt that the bats the club has aren't very good, maybe trying something new would be cool.

Donal – it's a real motion. Think £340 is an upper limit, don't think would be an issue with cutting it down to purchase just one.



Felipe – Want to spend £340 on a cricket bat?

Donal – two

Felipe – Why are you two proposing and seconding, you’ve never played cricket in your life!

Donal – I’ve played once...

Felipe – what is your interest in Corpus cricket?

Donal – bringing this motion on behalf of James

Jonny Earl – what are the cricket provisions at the moment?

Gareth – club currently has to bats in good condition, one other and two smaller not so bad. Can we move to debate?

Shannon – how much did the other bats cost?

Gareth – mine is £150, a perfectly functional one would be £90-£100

#### Points of debate:

Gareth – these cricket bats are not good cricket bats, are gimmicky and pointless,

*[Secretary notes: Gareth gives knowledgeable explanation and example of the cricket bat during a match, but due to Secretary’s ineptitude at sport she is unable to understand and record it properly. Apologies.]* They don’t improve performance, don’t improve anything, doesn’t matter about article Pontifex read. £340 is a lot for two bats. Why are we asking JCR for money right now when we are currently in discussions with Univ grounds that we require £700 from JCR, the email from Ponti came at 12 o’clock today. This is a waste of JCR money

Greg – relative to their costs, boat club tried to limit their costs to what they needed; don’t see the return here, I trust Gareth when he talks about cricket bats.

Donal – think the prices aren’t as steep as motion would suggest

Gareth – they are, they’re hyper inflated prices because they are gimmicky.

### Short factual questions

Gareth – felt that had overriding feel of JCR believes that we should stay at the median, couldn't that be read like that by SCR and send us up proverbial creek without paddle?

Jack – last year we agreed to stay at the median until accommodation improved.

Gareth – does it say 'always'?

Jack – think so

Gareth – important difference.

Greg – whose idea was it in the questionnaire to devote that much space to hardship fund, which is only a little bit related to rent issue?

Jack – it was the model sent by OUSU

Greg – did you approve the decision?

Jack – yes.

Jonny – is there any provision to begin rent proposals before we choose accommodation, to give us the option of going private?

Jack – wish we could, but every other JCR in uni does their proposal in Trinity term, it's just how it goes. Ballot being moved to Michaelmas.

Sam Robberts – can International storage be included?

Jack – been included last minute, yes.

Gareth – if talking about rent and accommodation, why is the sportsground and college bar involved?

Jack – in previous meeting, we talked about this.

### Points of debate

Gareth – feel that if talking about rent then should focus on accommodation stuff like finalists using JCR as point one, rather than having sportsground as our first grievance.

We should be talking about standard of accommodation.

Jack – in terms of stuff in my inbox, sportsground is the biggest grievance

Greg – last year when Seb was Pres and we had rent crisis and I talked to Val Cunningham. He said immediately that if you don't like it, and can't afford it, is you go on the hardship fund. SCR think that that any rent proposal is justified because you can get on hardship fund. But SCR also say that if on hardship fund also means you can't have blues money, and can't get travel grants etc.

**Debate on the motion:**

Mek – I didn't know about this fund, didn't know it restricts your access

Dellar – I can't play Blues sports if on Hardship fund, because they get transparency to your finances

Colette Weston – nothing you do with money is your own any more.

Jack – since February this year, they have only prelim right to that, only right to see financial details you want to see them

Greg – Draconian review of finances, this is what I've gathered from tutors.

Jack – they only have access to your finances once when you apply, not the whole time.

Mike – also fair to assume that even only get a look at the beginning, you're still having to provide a budget, and if you want them to give you the money presumably in practice you're going to have to be giving up a lot.

*Greg leaves; Mike takes over the proposal of the amendment*

Jonny – if only look at finances one, how is that a problem for your liberty.

Dellar – not just about looking at your finances, also about the fact I'd feel guilty about spending money. Living like that is not particularly healthy or fun, or fair.

Jack – point is people don't know about the fund, don't know how many people are on it, as far as I'm aware no one has gone on it since I've been Pres

Joe – surely point is that because a Blues player is going to have to spend from the beginning more money, they should have to factor in

Colette – hasn't OOB been slashed/cut considerably?

Jack – no, it's actually being increased now.

Mek – bottom of page 4? Do we have any information than 26% of JCR what our standard of accommodation looks like.

Jack – OUSU do a quality survey, and we are actually quite high in that. Inflated due to Liddell as well

Gareth – asked Seb if OUSU have a definitive comparison or survey and he said not really. So perhaps something to discuss later

Jack – done in terms of, 'do they have an ensuite' etc

Gareth – that's not really the point, not an indication of quality.

Donal – this is a separate issue

Mek – can't ask OUSU to check everything, but what exactly do OUSU do

Jack – explains checklist

Donal – think we've covered a lot of ground here, suggest Jack makes an amendment that future discussions about the manner in which accommodation is rated and the Hardship

Jack – OUSU point noted, doesn't need amendment

*Move to vote*

Jack summarises: mandating paper, paragraph 6 being removed and replaced; stuff being changed re: cricket and sports ground; page 9 changes; and the bit about Blues
