### Motion One - VENDING MACHINES

This JCR notes:

### Motion Four - 'The Oxford Student' unsubscription

This JCR Notes:

- 'The Oxford Student' on a regular basis publishes potentially defamatory articles about our college and its members
- It is comprised of student journalists desperately trying to make a name for themselves
- The Oxstu shows little journalistic rigour or integrity
- Its expensive
- We get the same information better written in the Cherwell

This JCR Believes:

- In high quality journalism
- In the need to support fellow corpuscles
- It is morally wrong for us to finance attacks on our own college and the money could be more usefully allocated

This JCR resolves:

- To unsubscribe from the Oxford Student

- To mandate the JCR president to write a letter to the ~~oxstu and telegraph~~ expressing disgust at how the story was written
- To spend the money on a charitable cause. Journalistic charity. “journalists without borders”
- To mandate the JCR President to write a similar letter to other JCRs explaining our action

1. Anthony Collins - How much do we spend? £150 per term isn't it?

### Debate

1. Konrad Hepworth – we should know what they are saying, reduce to only 5 or 3 copies
2. Jim Everett – can get copies for free, this says we oppose oxstu's practises
3. Mike Hardy – this surely creates another story? There are problems with taking on the press, doesn't mean we should unsubscribe. People did want to read that story in the paper.

### ***Donal O'Hara takes the chair after Jack Ceddes it***

4. Anthony Collins– this is sticking our head in ground, could be seen as petulant, important to know what the enemy are saying, reduce not completely ban.
5. Millie Ismail – first four 'notes' apply to Cherwell, called us 'crapus Christi'. Quite likes oxstu occasionally.
6. Alex Franklin – fewer Cherwells, as we get so many?
7. Donal O'Hara – we previously tried to reduce numbers, but there was an issue of buying in batches
8. Gareth Langley – editorial board of oxstu changes over vac, victimising new editors. If they have written things that are so wrong, they can be formally blocked
9. Greg Yates – get rid of other papers as well. Don't buy the oxstu for journalistic integrity, we buy for other things. If they are slandering corpus, we should send a message. Legal question is moot, it takes time, this can happen now. Right to stand up for corpus.
10. Felipe Monge Imedio – this is a symbolic thing. He once had high opinions of oxford journalism but they just produce deformation and insults. Should stick with those in college. Proud to stand up against papers.
11. Nina Fischer– reducing number ruins the symbolism, legal issues take time and money to deal with. This is the best way.
12. Ilija Rasovic– symbolism is important. Chance to stop bad practise – tells other colleges and oxstu that we are serious. Need to do something, not be passive.
13. Jack Evans – about journalistic integrity. Don't publish articles that are right, sensical or checked or valid. People do have injunctions against the oxstu – others have to put up with oxstu. Right to have a Symbol just for 1 term.

14. Sam Kelly – good symbolic gesture. Will vote in favour – cautions about meeting having a very anti-oxstu opinion. Peoples JCR levy's going on the oxstu – wider opinion perhaps needed.
15. Jim Everett – really important personally. This term has caused lots of psychological stress for nothing more than being in the conservative party and have acquaintances do something silly. He made pictures in the mail, the telegraph, was talked about in the welsh national assembly, caused a lot of stress, went to doctors and now having counselling. Distressing that people in the JCR aren't supporting this issue –feels those against are saying that the press can do that to people, and we don't care about members. It is horrible and offensive. We need to show that we are all together, we say we are all together often, but we need to prove it.
16. James Gillespie – oxstu don't subscribe to PCC, so can't get retractions. Oxstu like to claim they are a nice newspaper but they aren't. The story isn't online because they would get sued. Moral issue – gossip columns have attacked Nina Fischer and Matt Ryder, this is about a journalistic culture where it is seen as fine to talk about personal issues. If this was spoken it would be bullying. We pay for this to be done, and that means we are buying into it. Important to stick up for our members who cant stand up otherwise.
17. Anthony Collins – symbolic gesture? Agree we should not accept oxstu practises but says the banning will have no symbolic effect and will go unnoticed. Cherwell will not report on it, oxstu will not care, and we wont know what's in that paper from then on. We should get a couple, we would then pay less money but know what is being said.
18. Sophie Kelley – not valid to say don't do it because it won't be noticed. It's like charity – a little action still means something. Other colleges will hear through word of mouth. Letter to the oxstu?

***Amendment – mandate the JCR president to write a letter to the oxstu and telegraph expressing disgust at how the story was written – Accepted as friendly***

19. Alex Coupe – we have good reasons and letter is a good way to explain why we are taking this action
20. Alex Franklin – good to write a letter to the oxstu, national papers dodgy – run past the SCR. Amendment – nationals pending SCR approval
21. Greg Yates – oxford papers have a right to talk about us, just not to publish lies. Best way to ditch all bad papers, would get news and would be a truly moral stand.

***Amendment – unsubscribe to Oxstu, Daily Mail, The Sun papers also –Hostile***

***Proposed - Greg Yates, Seconded - Francesca Petrizzo***

#### **Amendment debate**

1. Francesca Petrizzo – sorry for what happened in this JCR, was really unfair, but if we unsubscribe to just oxstu it would look like a strop. Mail and Sun equally bad journalism

2. Jack Evans – about one story, caused damage to JCR, prevented one candidate becoming JCR President. Story is about the oxstu, about ouca and hack-daq – published lies and affects others badly. Axe other papers in new motion.

**Amendment withdrawn**

22. Tom Hendriks – writing letters to nationals – not have any effect and muddies the issue

23. Felipe Monge Imedio– Anthony has an interest as he is involved in the JCR, we would do fine without the oxstu and we should put ethics first. Concerned about how we can morally finance the lies they tell

***Amendment – Mandate the President to get in write to other JCRs – Accepted as friendly***

***Amendment – spend the money on a charitable cause. Journalistic charity. “journalists without borders” - Accepted as friendly***

***Proposed - Jack Evans***

24. Nina Fischer– what are they doing wrong? When she was first written about, she received phone call the day before, accused of only achieving anything because of her looks and must therefore be sleeping around. Given only two hours to reply, sent blunt reply. Quoted the next day. In hack-daq two weeks later, attacked and article completely factually wrong. Happened the day before elections, was really upsetting.

Oxstu is despicable, but is the answer to unsubscribe. Surely we would want to see the articles. Symbolic gesture wont have an effect, and makes us seem immature. We need to know what the enemy are doing. Pragmatic to reduce the subscription, sympathy for those effected but this isn't the answer. Useful to know what they are writing.

**Proposition – speech – Ilija Rasovic**

We don't have an enemy, just people doing very bad things at the oxstu. Unsubscribing means we are actually doing something, will be seen as less petulant than just a stop. We are supporting fellow students.
