Offer of 4.11 % - is the estimated van norden index. Last years Van Norden has been adjusted to be higher, but the offer from college is still lower. College is overspending and the long term spending for the endowment needs recalibrating. The Bursar is new and doesn't want to be aggressive and he is willing to accept the rate of inflation, even though it is lower than colleges own costs.

Fighting would damage the relationship, and kezia isn't in favour of doing that.

Should argue for a few concessions.

Greg Yates – if we did do direct action could make concessions, but would rather get some things without that.

Kezia Lock – want to sweeten the deal for people

Nick Dickinson– outspending. Is anyone paying anything in college which is included in van norden already?
