This JCR notes:

- That paying for FIFA 12 became a little controversial last fortnight.

This JCR believes:

- That though retrospective payments are not unconstitutional, they are frowned upon.
- That the purchase of FIFA 12 represented something of an awkward special case since someone would have to have asked for money at the end of the summer term to prevent the payment from being retrospective.
- That these two factors largely explain last week's kerfuffle.
- That we can prevent this from ever being a problem again if we adopt one of the following resolves.

This JCR resolves:

- ~~1) EITHER to amend the clubs and socs officer's standing orders to allow for the purchase of video games.~~
- ~~2) OR to amend the cinema curator's standing orders to allow for at least £40 of the cinema budget to be spent on games each year.~~

Motion Nine - Gender Inclusive Language Motion

This JCR Notes:

- Corpus is a welcoming, friendly and equal place,
- That Corpus should try to accommodate any member of the JCR regardless of their gender identity
- That trans-identified people are often inadvertently not accommodated by the university

This JCR believes:

- That Corpus should explicitly ensure that trans-identified people are accommodated by the JCR

This JCR Resolves:

- To encourage members of the JCR to be as gender inclusive as possible in the language that they use.
- To mandate the JCR President to review all emails forwarded to the JCR Mailinglist and check for non-inclusive gender language, for example the following:
- Instead of 'Girls wear dresses, guys wear suits' use 'Suits and dresses'
- To make it clear that when the JCR runs gender specific events, anyone who identifies as that gender is able to and welcome to attend
- To mandate the Male & Female Welfare Officer to ensure that the first Welfare Tea email of each term includes the provision that they are open to all who identify as that particular gender.
- To mandate the Equal Opportunities officer to monitor the implementation of the previous resolves
- **To put the top four resolves into the JCR Policy document**

Seconded – Olivia Chinwokwu (Equal Opps Pres)

Short Factual Questions

Greg Yates – when you say transgender, which do you mean? Transsexual, intersex, third gender?

Goh Li San - Stonewall cover them all

Greg – they don't

Olivia Chinwokwu – sticking with the campaign

Rachel Dellar – if there's not a distinction, people couldn't make the transfer between genders that they want

Ivan Dimov – to what extent should we use gender neutral language?

Goh Li San – use good judgement, and be as inclusive as possible

Olivia – summarises the motion – aim is to be inclusive, not limiting the use of 'he' 'she'

Steph Cherrill – aren't we inclusive already? Is there a need for this? Is this just a clarification?

Olivia – just showing our support for the campaign with this motion

Felix Neate – what problem does this solve?

Racehl Dellar – what about sport that is gender bias?

Olivia – not policing massively, and we respect divisions

1. Greg – He is opposed, finds it insulting that we even need to pass this, corpus is so implicitly trans-friendly
2. Dellar – other JCR's could follow our lead
3. Anthony - Johns and Univ already passed similar motions
