#### Motion One - LGBT History Month Motion

The JCR notes:

1. That February is the 8<sup>th</sup> LGBT History Month in the UK.
2. That the purpose of LGBT History Month is to promote understanding of the histories of lesbian, gay, bisexual and transgender people in Britain and Northern Ireland.
3. That several Oxford colleges such as Wadham, Mansfield, and New College plan to fly the Pride Flag over college on February 29, 2012, to celebrate LGBT History Month.
4. That Corpus' policy is to fly only the union or college flag, over college.

The JCR believes:

1. That Corpus should join with other Oxford colleges in a show of solidarity with the LGBTQ community this year during LGBT History Month.
2. That Corpus should put rainbow bunting over college on February 29.
3. That Corpus should support the flying of the Pride Flag.
4. That the JCR should ask the governing body to reverse this policy, so that the Pride Flag can be flown in future years.

The JCR resolves:

1. To mandate the Spectrum/Equal Opps Rep to order and put up rainbow bunting over college.
2. To mandate the President to ask the governing body to reverse their flag policy at the next Governing Body meeting, so as to allow the Pride Flag to be flown.
3. To buy a new Pride Flag, as the old one has gone missing again.
