## **Constitutional Motion**

### [Motion One – The Great Constitutional Reform Act](#)

This JCR notes

1. The JCR constitution is in need of great reform as parts of it are unworkable
2. The reform of the constitution requires this motion to pass in two successive JCR meetings

This JCR believes

1. The JCR constitutions should be in good working order so as to avoid unnecessary arguments amongst people in the JCR

This JCR resolves

1. To make the following amendments to the JCR constitution
  - a. Clarify the positions on committee and make sure they correspond with the Standing Orders, and to add to Article 5, statement 1 the position of Arts Officer to be on committee
  - b. The remove all references to a separate charities officer, and ensure that it is instead a Charities and RAG officer
  - c. To add to Article 7, statement 1, regarding the policy document, “to be renewed annually at the third JCR meeting of Michaelmas term in a series of votes on each policy”
  - d. To remove annoying repetition and ambiguities in the language of the JCR constitution, but not to change the spirit of the document in so doing.

- e. To add to Article 4, statement 10 “A contested by-election will be organised in the same manner as all other elections. In the case of an uncontested by-election, the single nominee can, at the discretion of the President and the Vice-President, be proclaimed into the office they seek by the **use of a paper ballot in passing of a motion** in the next JCR meeting with a 2/3 majority. If they don’t get a 2/3 vote, nominations re-open at the close of the JCR meeting and the next election will happen in the regular manner.”
- f. To add to Article 6, statement 63 “the Vice-President is permitted to state the constitutional position on what the JCR is discussing when s/he deems it necessary to be known.”
- g. **In trinity term, reduce the quorum to 20**
- h. **Have the agenda sent around the JCR by noon Friday, not 9am, as it currently is.**

*This JCR believes:*

- That formal hall used to be free for challenge competitors, but our stingy rivals are now charging us £10.80 per head, and a free formal would be an apt reward for those fortunate enough to get onto formal
- Since the 'fun' helicopter and blender motions were shot down, the JCR has a bit of money to spend. What better way to spend JCR money than on something that represents the JCR and that the majority of its members are getting involved in?

*This JCR resolves:*

- To entrust the Clubs & Socs officer with £3000 to fund transport for our competitors and supporters, and to then clothe and feed them

Coach Transport - £1975 (79 seater for £1250, 50 seater for £725)

T-shirts - £600 (80 T-shirts)

Formal Hall - £540 (£10.80 x50)

Refund from Cambridge for damages - £150
