# **Ambiguous Abstentations**

- 1. This JCR notes;
  - a. JCR members have the ability to vote for, against or to abstain in respect of a motion
  - b. For motions requiring a 2/3 majority, under section 15 (VI), a motion shall pass "if the number of votes for it is at least twice the number of votes against it"
  - c. For a simple majority, under section 15 (V), a motion shall pass "if and only if the number of votes for it exceeds the number of votes against it and the number of abstentions and spoilt ballots"
- 2. This JCR believes;
  - a. That section 15(V) of the constitution is ambiguous; does it mean;
  - b. A) that the sum of abstentions, spoilt ballots and against votes must exceed the number of for votes
  - c. B) That anyone of these may exceed the number of for votes
  - d. A coded constitution should try its best not to be ambiguous
  - e. It is illogical that if a motion pertains to expenditure or the constitution then the determination of whether a motion passes or fails is based upon there being 2x more for votes than against, whereas for a simple majority abstentions are counted alongside the against votes
  - f. That the definition of special resolution given under section 2, is different to the definition of a 2/3 majority given under section 15 (VI)
  - g. That this is also ambiguous and could leads to an abstention becoming equal to a no vote
  - h. JCR motions in the past have failed under a simple majority but would have passed under a 2/3 majority
  - i. Abstention is defined as "an instance of declining to vote for or against a proposal or motion"
  - j. It is as a result wrong for it to be counted alongside for or against votes
- 3. This JCR resolves;
  - a. To amend the constitution as follows;
  - b. Section 15 (V) to read "If a motion requires a simple majority to pass, the motion passes if the number of votes for the motion exceeds the number of votes against the motion, unless the number of abstentions or/and (in the event of a secret ballot) spoilt ballot papers exceeds the number of those voting for and against the motion"
  - c. That this definition of simple majority will be used in all instances where simple majority is referred to in the constitution; notably, but not limited to, the following sections;
  - d. Section 6 (IX)

- e. Section 11 (IV)
- f. Section 13 (IX)
- g. To amend section 2 Special Resolution to read "Special Resolution-This means a resolution passed by a 2/3 majority of votes cast by members at a JCR meeting, consistent with section 15 (VI)"

Tyron Surmon Seconded: Alex Grassam-Rowe

# Motion to Donate to Oxford Pink Week 2019

- 1. This JCR notes:
  - a. Oxford Pink Week is a week of events in Hilary Term, this academic year it will take place in 2nd week, Hilary Term, 2019
  - b. Pink Week supports three breast cancer charities: Breast Cancer Care, Brest Cancer Now and CoppaFeel
  - c. Breast Cancer Care: is the only specialist UK-wide charity in the UK providing care, support and information to anyone affected by breast cancer.

- d. Breast Cancer Now: the UK's largest breast cancer research charity. Their aim, by funding almost £25 million worth of cutting-edge research, is to achieve a 100% breast cancer survival rate by 2050. They also engage in political action so the NHS can guarantee that women with breast cancer can get the treatment they need.
- e. CoppaFeel! is a breast cancer awareness charity, based in London. The charity focuses on promoting early detection of breast cancer by encouraging woman under 30 to regularly check their breasts.
- f. 23% of breast cancer cases in the UK are preventable (UK, 2015), hence the importance of CoppaFeel's work
- g. There were 55,122 new cases of breast cancer in 2015 in the UK and 11,563 deaths from breast cancer in 2016
- h. Breast cancer is the 4th most common cause of cancer death in the UK, accounting for 7% of all cancer deaths (2016)
- i. Breast cancer is the second most common cause of death in females in the UK
- j. A key feature of Pink Week is Pink Night alongside other events, these events are fantastic fundraisers but require large deposits and upfront expenses. £300 from the JCR would allow Pink Week to run these events. After the event this money will be returned to the Pink Week fund when we get our deposit back the £300 is therefore not only a donation to a fantastic cause but also a way to make this money go much further
- 2. This JCR believes:
  - a. That this is a cause the JCR should be supporting, because breast cancer is a cause that is dear to many people's hearts as the disease affects males and females.
  - b. Corpus JCR has a great history of donating to worthy charitable causes and this is something they should continue to be doing
  - c. Oxford Pink Week is a student-run initiative, until and unless we can secure sponsorship it will not happen without money from generous college JCRs
- 3. This JCR resolves:
  - a. Mandate the charities officer to include pink week on the list of charities that we can vote on

Carys O'Connor **Seconded:** David Brown

#### SFQ:

Lucie: Would this come out of the charities budget? Lil: No. Lucie: How many other JCRs have donated? Carys: So far six but the others are voting this week. Arjun: Did we do this last year?

Ryan: Don't we have a charities ballot for this?

James: Is there a time before which the money must be given?

Carys: Seventh week.

Lil: Where does £300 come from?

Carys: Based on what they needed last year. Deposit was 2,100 and food and drink 1100.

Sebastian: Is there space in the budget for this?

Ryan: Yes.

### Debate:

Tyron: Would it not be better to follow how we normally do charity money and make it an option in the charities ballot? Then it would come out of the levy. Carys: On the charity ballot it might go straight to the charity.

Tyron: I think it would still go straight to the fund through the ballot.

Ben: Last term we gave money to the tortoise fair outside of the charity ballot. Would probably be more than £300 too through the ballot.

Lil: Mandate the charities officer to include pink week on the list of charities that we can vote on (seconded by Tyron). Point of information would mean the JCR would vote again on the charities.

Shiv: This is no longer a monetary motion so now just needs a simple majority.

Matt: Would this mean it would be at the expense of other charitable causes? Tyron: Yes but we donate to loads like 8 or 9.

Lil: The charities levy on battels goes to a fund from which we choose charities by this ballot.

Ryan: Two charities get 750 and six get 200.

Ella: If they're doing it based on what they got last year and more donate this year 250 will be enough.

Lil: Sometimes JCRs give less if they are just smaller.

38 in favour. 4 abstentions. This motion passes.

6 in favour. 16 against. 15 abstentions. This amendment fails.

James: How many laundry sites are there?

Ben: There's one in Liddell under Chch and two in Lampl and one in Walton and one across from Banbury. In Walton I never had an issue with that but in college I did.

Tyron: If I amended it to include Liddell would you oppose it?

Alex: Now I think about it, it happens at Liddell too. In college there are second years, third years and grads. Liddell also has an issue.

Tyron: To mandate the DO to spend up to £50 on as many laundry baskets as he sees fit (seconded by Helen – taken as friendly).

Ben W: Same applies to Banbury as there are grads there.

Lil: Can you label them with Sharpie so they don't get stolen? Ben: Yeh sure.

41 in favour. None against. No abstentions. This motion passes unanimously.

# Printer for offsite college accommodation blocks

- 1. This JCR notes:

### SFQ:

Aex: Do you think college will take charge of this?

Helen: I think it's a very reasonable thing to bring to college and something we should raise.

Lucie: I understand the library staff currently look after the library printer. Who do you think would look after that?

Helen: There is one in the library suite so it's not solely under library staff remit. There are staff on site there.

Lucie: They are porters and staff.

Ryan: Liddell is Chch owned have you asked if they're ok with it?

Helen: I asked the postgrads and they said the Chch students don't have one. There's room in the common room for it.

Lil: You and Eve so you bring it to JCC. To mandate the academic affairs and suspended students officer and the JCR president to raise the issue of having a printer in Liddell at the next JCC meeting (seconded Grassam – taken as friendly).

- 1. This JCR Notes

Nicolle: Could we not say it could be a shortlist of five possible final songs and work through them throughout the term?

Matt: I think the point is so when we know it's coming we all head down there together.

Lucie: How are you going to check that the songs are suitable to be shouted at a bop? Matt: Chris is a master of these matters.

Chris: I think choose it termly not yearly.

Lucie: What's the point? That's not long enough.

Chris: Mandate the entz pres to choose the winner for a term not a set period of time (seconded by Ryan – taken as unfriendly).

Dempsey: Is there an exception for Christmas?

Arjun: I think a term is too short. I think it should be a year.

Sebastian: Just because one song is guaranteed to be the last song doesn't mean the rest can't be played in the bop.

Matt: It could be that the song changes only when people are tired of it. So not necessarily a definite period of time.

0 in favour. 27 against. 10 abstentions. This amendment fails.

Chris: Amend to change set period to a year (seconded by Alex – taken as friendly) Tyron: Amend to mandate the entz pres to always play angels except at Christmas (seconded by Helen – taken as unfriendly).

4 in favour. 30 against. 4 abstentions. This amendment fails.

Lucie: You said you were a fresher.

Matt: I was last year.

Lucie: You've only been here a year. The thing is that's not very long and the number of bops in one year isn't that many. Not long enough to develop sentimentality.

Matt: By asking the question every year it makes it seem like it should be changed. Matt C: If something that's voted for we'll only know we love it when we're in the BC.

Ryan: I think this is a slippery slope. We could start mandating the first song and the last song and so on.

Caleb: when would it be voted on?

Chris: I think it should change with the entz pres.

Caleb: Amendment to add to the entz pres' standing orders to run a poll at the start of his term for the final bop song which will then be in place for a year with the exception of the Christmas bop (seconded by Arjun – taken as friendly). James: Move to yote (seconded by Russell) passes upanimously.
