Empty Equal Opps Roles Are Bad (and some Constitutional Cleanup)

This JCR Notes:

- 1. That empty Equal Opps (henceforth E.O.) Committee roles are bad
- 2. That the responsibilities of an unfilled role on the E.O. Committee are currently passed onto the E.O. President
- 3. That not all Constitutional references to the defunct Socio-Economic rep have been appropriately replaced by those to the Access and Admissions Officer

- That introducing a trans* rep demonstrates Corpus' commitment to progress, equality and inclusivity

This JCR resolves:

- To create the role of Trans and Gender Minorities Representative to the Equal Opps Committee, and amend section 21.II. of the Constitution as appropriate
- To amend item 6. of the LGBTQ+ representative's Standing Orders to: "To organize an event in Freshers' week, in liason with the Trans and Gender Minorities representative, for LGBTQ+ Freshers." To add new standing orders as per Appendix A:

Appendix A:

- Trans and Gender Minorities Representative
- Elected: Trinity Term of Office: One Year Committees: Equal Opportunities Committee
- Duties:
- 1. To represent JCR interests on the above committee, and to keep Junior Members informed of developments.
- 2. To provide a focal point for student welfare in college, with particular emphasis on issues for transgender and minority gender students, and act as a signpost to transgender-related welfare services in college, in the university and more broadly.
- 3. To publish in College all transgender- and minority-gender-related welfare information from the College, University, Oxford SU, NUS and LGBTQsoc via the welfare board and JCR welfare website.
- 4. To liaise with Oxford SU in connection with its transgender-related welfare services, including attendance at any Oxford SU transgender-focussed welfare groups.
- 5. To liaise with the university LGBTQ society, distributing any relevant information about entz or welfare.

Funding the NEW CORPUS CHRISTI COLLEGE OXFORD JCR INTERNATIONAL STUDENT SUMMER VACATION STORAGE SCHEME (NCCCOJCRISSVSS) *inhales deeply* [henceforth referred to as 'The Scheme']

This JCR notes:

- 1. That International Students make up nearly a quarter of the Corpus Christi College JCR.
- 2. That International Students need a place to store their possessions over the summer, as flying them home would be expensive and cumbersome.
- 3. That Corpus Christi College is sadly not able to provide International Students with a complimentary storage room for the summer vac, necessitating students to use other storage options.
- 4. That the same applies for Domestic Students who cannot be picked up by their parents, because their parents do not own a car, because they live independently from their parents and/or because they live far away (e.g. Scotland) and have to take a flight just like the International Students.
- 5. That said other storage options are, in every case, not free.

This JCR believes:

- 1. That International Students, who in many cases pay significantly higher tuition already, should not be burdened too heavily with additional costs merely because they live far away.
- 2. That subsidizing International Student summer storage (NCCCOJCRISSVSS) would be the right thing to do.
- 3. That providing liquidity in form of a temporary and fully repayable loan to the International Student Officer, who will be having to pay for this storage scheme upfront and will not be personally profiting from this, will help ensure that this project (NCCCOJCRISSVSS) lives to

see the light of day, meaning that students will not have to use significantly more expensive storage options such as "Lovespace".

This JCR resolves:

- 1. To subsidize the NCCCOJCRISSVSS with a fixed amount of £500, which amounts to roughly 40-50% of the total costs, therefore nearly halving the financial load that International Students have to shoulder.
- 2. To grant the International Student's Officer a loan of £1000, which he may use to pay for the cost of the NCCCOJCRISSVSS until the costs are refunded to him by the International Students. The loan must be fully repaid by December 2019 and is interest free.
- 3. To mandate the JCR President and International Student Officer to lobby college in a quest to have at least a significant portion of the £500 paid by college as opposed to being paid from JCR funds.
