Motion to reduce food waste

This JCR Notes:

- 1. We are provided with excellent food by our kitchen team, for which we are very grateful.

- 3. Food waste is a significant contributor to our impact on the environment

This JCR Believes:

- 1. We should be trying to minimise our impact on the environment
- 2. Hall food should cater to all appetites large and small in order to promote a healthy lifestyle

This JCR Resolves:

- 1. To mandate the DO to ask the kitchen team to make it official policy, if it isn't already, for those purchasing food to be able to ask for smaller or larger portions and that all staff be briefed on this

Schwarzman Motion

This JCR notes:

- 1. Stephen A. Schwarzman is the co-founder and chairman of global private equity firm 'The Blackstone Group'.
- 2. In August 2019, it emerged that two companies owned by Blackstone are 'significantly responsible' for deforestation in the Amazon. (The Intercept)
- 3. In a 2019 report, a UN report identified Blackstone as a significant contributor to the global housing crisis, concluding that their business practices violated tenants' human rights.
- 4. Schwarzman is a donor and former close advisor to Trump. He has also been a key donor at the Koch brothers' donor summits, which have been responsible for legitimising hard-right ideas and climate denial through donations to academic and cultural institutions.
- 5. The University's faculty boards learned of the donation from the press before being consulted. This announcement happened when students were sitting exams and academics marking finals, meaning the initial open meetings for consultation took place outside of term-time in July.
- 6. The donation was referred to the University's Committee to Review Donations and Research Funding. However, the donation's negotiations and its review are subject to NDA's, meaning they are incapable of being examined.
- 7. An open letter requesting transparency on the matter with ~100 signatures from academics, councillors, student and community groups has been circulating since September 17, with no response from the University.

This JCR believes:

- 1. It is through association with universities like MIT, Yale, and now Oxford, that Schwarzman seeks to legitimise socially and ecologically destructive practices.
- 2. As a public institution that claims to value the pursuit of truth, the University should not be willing to disregard Blackstone's and Schwarzman's record without clear justification and consultation.

This JCR resolves:

- 1. To mandate the JCR President to request that the University release the full details of its vetting process of Schwarzman's £150m donation so that a public review of said process can take place.
- 2. Request that a transparent ethical framework for donations be demonstrated such that donations may only be accepted when they are consistent with the University's stated values of sustainability and equality.

3. Request that the University release information as to Schwarzman's ongoing influence on the Centre – i.e. the extent of his involvement, access to the Centre, what honours he will receive.

Motion to put pressure on Oxford nightclubs to increase security to prevent spiking by signing an open letter

This JCR notes:

- 1. Official figures have shown that the number of drink-spiking cases in the UK have more than doubled in the last three years.
- 2. There has been a 108% rise in the number of reports to police forces across the UK since 2015.

- 3. However, officials believe the figures are significantly lower than the reality because victims often do not report having their drink spiked.
- 4. Park End have CCTV but admitted on a phone call that it does not cover everywhere.
- 5. Drink spiking can cause hallucinations, speech difficulties, memory loss, loss of inhibitions, vomiting, seizures, loss of consciousness and mental confusion needless to say, drink-spiking is often traumatic for its victim.
- 6. The majority of drink-spiking victims are women.
- 7. Drink spiking can lead to theft and sexual assault/violence; with cases against current St Hilda's students known.
- 8. Many cases of drink-spiking go unreported, due to fear that they will not be taken seriously by police, and due to a lack of memory regarding the identity of the perpetrator.

This JCR believes:

1. That it is our duty as a college to use our platform to communicate with prominent Oxford nightclubs to improve their security, as well as trying to involve the JCRs of other colleges.

This JCR resolves:

- 1. To apply pressure to the nightclubs, particularly Bridge and Atik/Park End, to try to find a better way of managing security.
- 2. For the president to sign an open letter to nightclubs to call on them to improve CCTV and security.
