Environment & Ethics Committ-E&E

This JCR Notes

1. Working to make Corpus more environmentally-friendly and ethical is important

- 2. Making Corpus more environmentally-friendly and ethical is a full-time job with many different aspects, from waste management to negotiating divestment from fossil fuels
- 3. The E&E officer is only one person and cannot effectively tackle all these problems alone
- 4. There is an element of time-pressure to meet environmental targets given the nature of climate change
- 5. More E&E work can be done by more people

This JCR Believes

- 1. An E&E committee, modelled on the Access committee, would be able to assist the E&E Officer in their role by spreading the workload and making change happen quicker and more effectively
- 2. Assigning more people to E&E would reflect the JCR's commitment to sustainability and tackling climate change, on a par with issues of Access or Equal Opportunities

This JCR Resolves

- 1. To create an Environment & Ethics Committee with a maximum of 3 appointed positions, appointed by the E&E Officer and the JCR President
- 2. To allocate roles to the 3 appointed committee members such as (but not restricted to) Divestment Representative, Waste Representative, and Ethics Representative
- 3. To amend the constitution as per appendix A
- 4. To add new standing orders as follows:
- i. The E&E Committee. Appointed: Hilary. Term of Office: One Year. Committees: E&E Committee. Note: up to 3 to be appointed.
- ii. To represent JCR interests on the above committees, and to keep Junior Members informed of developments
- iii. To assist the E&E Officer in making the JCR and the wider college a more environmentally-friendly and ethical institution
- 5. To add to the standing orders of the E&E officer:
- i. To appoint up to 3 E&E Representatives in Hilary for one year.

Appendix A:

I. The E&E Committee shall assist the E&E Officer in making the JCR and the wider college a more environmentally-friendly and ethical institution, including campaigning for divestment and that the College become a living wage employer (as per the policy document)
