Advertising empty Equal Ops positions

This JCR notes:

- Recently the RO encountered difficulties when a member of the JCR requested to run for Trans Rep in the recent by-elections.
- The position, though empty, was not put up for election. This was in accordance with §21.V: "The responsibilities of an unfilled role on the Equal Opportunities Committee shall be subsumed by the most appropriate representative on the Committee and/or the Equal Opportunities President"
- The constitution stipulates (§27.I) that "The Returning Officer shall advertise for nominations not less than ten days before the election takes place." The JCR member therefore requested that the position be put up for election too late.

- This led to the RO being constitutionally unable to offer the position of Trans Rep for election in the by-election, despite someone wanting to run for it.
- The position of Black and Minority Ethnicities (BME) Representative was put up for election, though the same rules apply to BME as to Trans Rep.

This JCR believes:

- It is good to have representatives for as many Equal Ops positions as possible.
- Offering the positions as up for election in by-elections is more likely to encourage people to run for them.
- If a JCR member wishes to run for any Equal Ops position, that should be encouraged.

This JCR resolves to:

1.Amend the constitution, adding a clause to §26 that: "In the event of a by-election, any currently unfilled positions on the Equal Opportunities Committee should be put up for election by default in the by-election, provided that this is in accordance with §21.II."

2.Make a further amendment to §21.V, appending the following: "...until the role is elected in a full election or by-election."

Levies

This JCR notes:

- We can change the levies at the Trinity Term week 6 meeting each year.
- The survey done (more detailed results shown below) noted the majority of people:
 - feel that the levies are an appropriate cost verging on too expensive
 - feel that we should decrease the levies with the extra money from college (though this was very split and this has been considered)
 - feel that the charities levy is an appropriate cost
 - feel that we should introduce a cap on the levies and that this should be £30
- Comments on the survey noted that people often feel uncomfortable expressing their feelings about levies when conversations and surveys are held publicly. People noted that we can opt out of levies but there was also worry that opting out can feel shameful. It was noted that lots of colleges have no JCR levy which was part of the reason for the extra money from college.

This ICR believes:

- Listening to the results of the survey, we should be aware that the current cost of levies is appropriate verging on expensive when we consider additions to levies. We should decrease the levies using the extra money from college but also allow for extra money for events in the JCR. £5 levies taking into account the extra money from college will give us an extra £166 a term. We should maintain the cost of the charities levy. We should introduce a cap on the levies of £30 a term. This can be amended at each TT wk 6 meeting but will control additions to levies in motions throughout the year. We should note that public conversations about levies may not give representative answers as people may feel uncomfortable, and to give another way for people to express their opinion. We should think about different ways that opting out could work.

This JCR resolves:

- To decrease the JCR levy to £5. To maintain the cost of the charities levy at £10. To introduce a cap on the combined levies (excluding the punt levy) of £30 per term.
- To try wherever possible to allow surveys about levies to be anonymous. To allow anonymous submission of comments for motions which concern levies. To use a secret ballot for levy motions.
- To mandate the treasurer to think about other ways people could opt out and organise this.

SFQs/Debate:

- Alex: Is this constitutional, to bind the JCR to future anonymous voting
 - Florence: Have to have a 2/3 majority it's not too different to what we do anyway
 - Hannah: We would need a constitutional amendment
- Amendment, Ryan: remove part of motion that reads 'To use a secret ballot for levy'




Survey

What do you think of the cost of the levies? 61 responses




1 was too little and 5 was too much

With some extra money from college (thanks to Rhi and Ben), would you rather we decrease the JCR levy (£10 atm) or spend/do more in the JCR? 61 responses




1 was decrease the levy and 5 was do more


Do you think the charities levy is an appropriate cost at £10? $_{61 \text{ responses}}$

Pizza please!

- This JCR notes:
 - 1. COVID-19 is resulting in an increase in admissions into critical care units.
 - 2. Staff are under increased stress from a cancellation of leave, fewer days off, colleagues passing away from COVID-19, and a greater number of patients dying.
 - 3. AICU (adult intensive care unit) staff are under increasing pressure, with the number of admissions rising again after falling for a bit. AICU is the main COVID ICU for the Oxford Universities Hospitals (OUH) Trust. Staff in ITU are most at risk from aerosol generating procedures, which carry greater potential risk. AICU staff are having to wear multiple layers of PPE, limited to several hours at a time because of the harsh nature of wearing the PPE for so long.
 - 4. Pizza makes many things better.
- This JCR believes:
 - 1. It would be nice to do something for our staff up at the JR who are really facing SARS-CoV2 on a daily basis, and having to avoid their own families and facing stigma.
- This **ICR** resolves to:
 - 1. Utilize the money budgeted for JCR meeting pizza to instead buy pizza for the staff in AICU every Sunday night until the end of TT20.
 - 2. Mandate the JCR President to discuss with the MCR and College about contributing a similar small amount of money to show solidarity with the clinical students and Fellows of the College currently working across the Trust.

ME/CFS Awareness

This JCR notes

- The 31st May is the last day of ME/CFS awareness month (today)
- ME/ CFS are chronic illnesses that are incredibly stigmatised and was referred to in the 80's as yuppis flu
- It is also believed to be one of the conditions that constituted female hysteria in the victorian period
- Many patients with ME/ CFS are subjected to inhumane treatment, without the respect or dignity they deserve
- There is no effective cure or treatment
- 89% of patients receive advice that is actually detrimental to the condition (figure from patients advised under NICE guidelines)
- WHO recognises and defines ME as neurological
- ME occurs on a spectrum, causing extreme fatigue, dizziness, tinnitus, muscle and joint pain, brain fog, light sensitivity and more

This JCR believes

- Not many people are aware of ME and CFS
- The JCR should support and strive to educate itself about such disabilities

- to add "this JCR will endeavour to support and promote from college the supporting of all those with ME/ CFS" to the Policy Document
- To mandate the Disabilities Rep to hold a screening of Unrest on Netflix/Prime for the JCR, so they can learn a bit more about these conditions
