# AMENDMENT OF THE CONSTITUTION, MANDATES DOCUMENT, AND STANDING ORDERS IN RESPECT OF COMMUNITY OFFICERS

This JCR notes that—

- ❖ There are three Welfare Officers on the JCR Committee, who are the Welfare Officer (Equalities), Welfare Officer (Men's), and Welfare Officer (Women's);
- ❖ Though the most visible activity of the Welfare Officers is Welfare Tea, the Welfare Officer all have a variety of Standing Orders, such as ones relating to the signposting of support and liaison with Collegiate welfare;
- However, the role of the Welfare Officers does not emphasise, under the Standing Orders, the direct provision of welfare;
- \* Rather, it is the Peer Supporters and the resources of College, the Student Union (when affiliated), and the University which are intended to be the direct providers of services relating to welfare;
- ❖ For this reason, the College Welfare Committee has requested that the Welfare Officers be renamed, so as to clarify the responsibilities of the roles, with the necessary amendments to the Constitution and to the relevant annexes thereof.

This JCR believes that—

- It is appropriate for the names of roles to reflect the actual responsibilities of the roles;
- Furthermore, there are numerous outdated parts of the Standing Orders, such as reference to the nonexistent Access and Admissions Officer, which can be amended as part of this alteration;
- ❖ The name of "Community Officer" is a more accurate descriptor for the role of the current Welfare Officers, because a lot of the tasks of the Welfare Officers are related to engagement in the Corpuscular community;
- ❖ Therefore, it is warranted to amend the Constitution, the Standing Orders, and the Mandates Document to reflect this renaming and to correct minor errors.

Procedural motion passes

Michael: The main bulk of it is changing the wording "Welfare Officer" to "Community Officer" in the Constitution. As far as the Standing Ofrders go, a lot of them are to do with tightening things up that had previously been said and to clarify that this is a signposting role and not a supporting role. The conversation with College essentially boils down to this: they don't think that first-years should be able to hold welfare positions, because Welfare Officers, while they can be peer-support trained, more often than not, they are are not. And, as a result, they lack any formalised training in welfare, where if something were to happen, it could be looked at as College having first-years, who are potentially in their first or second term of University, being supposed to provide welfare to people. This constitutional Standing Order change is to do with making the role a signposting role rather than a directly supporting role. That's supposed to be left to peer supporters who have had thirty hours of peer support training and regular check-ups and it is supposed to be left to College Welfwre. In terms of the day-to-day role of the Welfare Officers, this won't change overly much. They will still be doing JCR Teas, Welfare Week, and Welfare Tea. It just makes it very clear that they should be signposting any issues that people have rather than actively trying to support them themselves, because they have no formalised training. And, because of these changes, it means that Freshers are still available to run for these positions. This is because it was College's position that, if we didn't change this and we kept Welfare Officers as they were, you would only be able to run or hold the position if you were a second-year or above, and, considering the size of our committee, we can't sustain not having first-years. Welfare is normally a good route for Freshers to get involved in, so we were fine with this change being proposed, namely to Community Officers, because it still reflects the actual role of welfare on a day to day whilst also keeping or allowing freshers to run for committee. That is basically the changes.

Short, factual questions:

Elias: Can I clarify, in terms of College making decisions, is this a response to what happened last year?

Michael: This is what the College Welfare Committee decided on and recommended

Ben: I would like to clarify as well, this brings us in line with a lot of other Colleges. Peer supporters has two supervisions a term, and it starts with each peer supporter talking about how welfare works in each of their Colleges. Over the last three years there has been a marked trend towards peer supporters essentially becoming a more prominent role while welfare takes more of a signposting and communities angle. I think the best example is Queen's, who have a very clear divide, so this is not something being imposed on to us. This is a way of modernising the way of the rest of the University. This is in my personal opinion a much better progression towards it.

Michael: To clarify, this isn't what College has told us to do. All of the changes, including the name, everything was something that we as Exec came to them with as our compromise. This is becausee they were quite hard on not having to change the Standing Orders and wanting first-years not to run. So, everything that is written here is not something that College is putting on us. It is something that we have come to them with as a compromise.

Debate:

Elias: I would like to raise the point that the Welfare Officers did a really amazing job last year during a really tough time. I don't really like the implication behind this.

Sam M: I kind of agree that first-years shouldn't be doing that anyways. I think that if you asked me in first-year, I would have said "yes" but now being older I should have said "no". I think it is something that you do realise as you go through the years. I mean that, if you have not even gone through your own set of exams yet, in those kind of situations, it seems quite difficult to say to someone else that their exams are going to be ok when you have not even experienced them. I think that most of the things that people find stressful are the things that everyone has to deal with at the University and that usually people in older years will have experience in that already. I kind of agree with the idea that people who have just gotten to University aren't ideal for the position. Even with formal training, I think a lot of being able to sympathise with people is having been through those experiences yourself and knowing how people feel and knowing that it is going to be ok.

Michael: The point was made that a fourth-year could not look to a first-year for welfare support. My response to that is that I think that while Corpus is very good at cross-year-group blending, the reality is that there will still be a lot of cases where people will only talk to people in their yeargroup. And, I think that it is really important that within each year-group there is someone to talk to, because I think, in reality, it boils down to how different people are different. You might have a first-year comfortable talking to a second- or third-year. You might also have a first-year who is terrified to walk into the JCR. I think that it is really important that each year has someone to go to, not even necessarily just for welfare support, but for advertising events such as Welfare Week. Things like Welfare Tea and Welfare Week would be more attended if there is someone in each year group that says, "I am running this event, you should come", compared to a second-, third-, or fourth-year posting on Facebook. I get what you mean about not wanting a first-year to do it, but I also think it is the case where there are three levels of testing before a person can be a Welfare or Community Officer. There are the hustings and the elections themselves, where the people decide whether that person is up for the task. Then, there is their tutor, because College will also be cracking down on tutor permission, where you can only get tutor permission from a fellow on Governing Body. You will have tutor permission as well. We are also talking about, specifically for Community Officer positions, that they will have to have a conversation with the Student Support Officer, Katie Rudaz, or Mark Wormald, who is the new Dean of Welfare, where they can have a half-hour conversation and they can assess whether they would be in a position to do it. So, I get what you are saying about the risks of first-years.

Ben: I would like to raise more points about peer-support training. I think that it is worth pointing out that a lot of peer-support training isn't so much about directly supporting people and dealing with it yourself. I have this giant booklet in my drawer of signposting of actual support in College, University, and external: a lot of directing to actual trained professionals. I can just email our supervisor and ask to connect someone with another peer-supporter in a certain year, if that is the case and is something that would make them more comfortable. I have done that. There is a wider network. If Corpus admits this change, it's not going to undermine a bunch of pillars. There are lots of behind-the-scene systems. The whole point of peer-support training is to primarily get you in contact with trained professionals.

JJ: The only issue that I see with this is, for example, if in my Freshers' Week someone directed me towards a Community Officer, who I can go to with any concerns, it seems secondary school. I am not sure I would want to go talk to a Community Officer, but, if you said a Welfare Officer, I know a bit more. Community Officer feels a bit more like they are there because they have to be and not because they actually serve a role. That is my opinion. I feel like this is something that we can informally say, for example in Freshers' Week, that this is basically like a welfare person but they are called the Community Officer.

Michael: I get what you are saying. The truth is that the name has to change because if not, we won't be able to allow first-years. Welfare Officers have largely become Community Officers in the sense

that they provide welfare to the community rather than to individuals, whereas peer-supporters are from individual to individual

Tom: I find this motion to be quite insulting. Why should I vote for it?

Ben: In actual terms regarding welfare, it has been conversation that I have had with people in other Colleges. There has been a needed change as to how welfare should change and utilise peer-supporters more. I have been trying to think of a way for a while how to do this. Peer-supporters have put a lot of effort with the training and are just more direct lines of access

Michael: Community Officers will still be doing the same role as a Welfare Officer, day-to-day. This will be a piecemeal change in that the most you see will be the name. It just means that, if someone has a welfare issue, they will be guided to someone who has training on how to support them, rather than to someone who the JCR thinks: "Oh, that is a nice person. They can help with this." This will mean that this person will be directed to someone who has been trained for thirty hours on how to deal with emotional responses. They will be directed to adults who have had years of welfare experience.

Elias: If the issue is around being trained, what if we made it mandatory for Welfare Officers to get peer-support trained?

Michael: The reality of that is tricky. Peer-support training is an immense time commitment, and even though College is managing to get a few more, it will just mean we won't have Community Officers, which means we won't have things like Welfare Tea.

Elias: I agree with Ben in that peer-support training is good and is important but we also could run into the problem of not having any peer-supporters. It is possible that the role of the Welfare Officers is lost after a few years.

Michael: The first thing I would say is the handover documents will be staying the same so all previous information from a given Welfare Officer transitioning to a given Community Officer will stay. The experience will still be staying the same. The Standing Order changes largely from the word "Welfare" to "Community" and a few of the Standing Orders that directly say that they are to support people directly rather than signposting have been removed. As far as losing the network of support, Community Officer will still have the same level of knowledge from the handover and they should still have the same level of regard for their position because their Standing Orders are very similar.

Ben: I don't want to keep pushing the peer-support stand, but I am going to. Looking at other Colleges and how they work and their divides, Lincoln MCR, for example, in Freshers' Week has both people there. They have the peer support team there and the whole welfare team. Their welfare team is similar to what is here. Some people also want to sign up to peer support training and not want to be a Welfare Officer. For example, I have matches every Saturday so I can't help out at Welfare Teas. That point aside, Community Officers can still chat about work, accommodation ballot, and so on. There people are still available to help and that is what the role has always done. Peer-support tackles slightly more on the nose, more complex things, more serious things to actual trained supporters. There shouldn't be, in any real terms, any change, as long as we keep up the effort that in the big introduction meeting in Freshers' Week that have clearly laid out what each Community Officer does. There will not be a great institutional loss of knowledge.

Michael: The Standing Orders are practically similar. The position of the existing Welfare Officers was still supposed to only signpost. Whilst Welfare Officers were told to help students, they were also told that when facing any serious issues to relay that to the trained people. All of that remains

the same. Largely, this will not change much because the position of the Welfare or Community Officer is still the same: to direct towards college and formal types of support

JJ: I don't know, but will having more peer supporters, actually make them more visible in the JCR? I will be honest, if I came here into the JCR, and I had a really bad day in labs and Fionn is sitting right there, I am gonna talk to Fionn, same with Mossy. I'm not going to lie, with the peer-supporters, I do not see them in the JCR as much as the Welfare Officers. I feel like having the Welfare Officers in the JCR in the welfare role makes them more visible, more friendly. I would talk to them.

Michael: That is largely the result of Welfare Officers being, as blunt as it is to put it, an elected position, where people who are in the JCR are more likely to run for a JCR position and then hold a JCR position. Peer-supporters aren't an elected position so they are far less likely to be people who you will find in the room. Whilst I understand that you are going to want to talk to people, this is by no means saying that you cannot have conversations with other people. The Community Officers still very clearly have in their Standing Orders that they are supposed to discuss with students. The only difference if you come to a new Community Officer and say that you are undergoing a very traumatic experience, and this is exactly the same as it was for previous Welfare Officers, they are not supposed to have it stop at them. They are supposed to pass that up to someone who has training. I get that you are going to talk to whoever is around you and that that is more likely to be a Welfare Officer than a peer-supporter, but that is the nature of someone in the JCR going to run for a JCR position who is then going to be visible in the JCR. Peer-supporters may not be as present in the JCR at the moment. That doesn't mean that they haven't always in the past. We are currently training more peer supporters.

JJ: It is just that, if the peer supporters are not visible in the JCR, that kind of defeats the purpose of them, because no-one is going to talk to someone who they have never seen or don't trust.

Ben: Politely, JJ, that is not, in my experience, how it works at all. You just get a private message saying: "Can I talk about this?". I get your point, but I tell you that is my job.

Sam M: I think it is just that the issues that people are dealing with peer-supporters aren't the types of issues that people would just bring up in casual conversation.

Michael: Casual conversation would be how the essay is going, the workload, or that kind of thing. For the new Community Officers, it is still the same thing, that level of support is still very much encouraged for a Community Officer to help someone with. It is for more serious things where it is going to require more than just a nice person and a good conversation. It is going to require training. And, so, the point still stands for the Community Officers that they will be the same as Welfare Officers that they are supposed to move them to people who have had that training.

Tom: Are we keeping the requirement for the Welfare Officers to do peer-support training?

Michael: There is not currently a requirement for it.

Ben: It was dropped in the CCCCCC.

Tom: Why should we not have elected peer-supporters?

Michael: I have never been a peer-supporter but I would strongly suggest to not having that be the case, because, currently, as it has been highlighted, there aren't that many of the peer supporters. To then make it that you have to be elected to be someone who can help someone in an emotional situation creates a lot of barriers for what is quite inherently a good thing to do. I just don't see the point in saying to someone: "No, you are not allowed to help someone just because you want to help someone. You have to run an election first."

Ben: It is worth mentioning as well that peer-support training is vetted. I know it might shock you that I was approved, but it is a vetted position. You have to make an application and an interview.

Rei: If this goes through is President then also a Community Officer?

Jacob: Yes.

Elias: I don't know if this is still happening but I know that last year the Welfare Officers were still having regular meetings with the Dean of Welfare and Student Support staff. Are they still happening this term and will they be continuing after this as well?

Jacob: The Standing Orders on that point there haven't changed.

## Ed: What is the order?

Jacob: There will be SFQs first. Then, there is a speech by the proposer, then a speech from Hector, then free debate.

Rei: Could the Executive Committee elaborate on the evidence that they thought made it was sufficient to be brought to the meeting?

Jacob: The Executive Committee voted: three in favour, one abstaining, and zero against to approve the motion on the evidence. I abstained.

Michael: The Environment and Charities Officer (E&CO) has not attended a single meeting of the Sustainability Committee - True. The E&CO has only partly attended the meetings of Green Impact - True. The E&CO only ran one event last term - True. The E&CO did not publicise any events relating to RAG or liaise with the RAG Committee last term - True. The E&CO did not perform a food collection at the end of last term - True. The E&CO either did not do or did not do on time his JCR Teas last term - True

Nat: Just to avoid any doubt, are all these things part of the E&CO standing orders?

Jacob: Yes. The first five are specifically part of the Standing Orders for the Environment and Charities Officer. The last one is also for every Committee member, but this is also part of the E&CO's responsibilities. It is part of the Standing Orders for all on JCR Committee.

Fionn: Are there any standing orders that the E&CO did fulfil?

Jacob: Yes, there are.

Speech:

Michael reads out the speech by the proposer

Speech of No-Confidence against the Environment and Charities officer

Over the last 3 terms, from his election to the position of Environment and Charities Officer in early Trinity of 2024, the E&C Officer has demonstrated a level of disregard towards his role as a representative of the JCR on environmental issues; apathy towards the JCR committee; and an overall lack of drive towards the responsibilities he said he was willing to shoulder when he ran for the position.

## Disregard towards environmental issues

The main college committee the F&C Officer sits on is the College Sustainability Committee, where he acts as the JCR representative. Since his election to the role of Environment and Charities Officer, the F&C Officer has failed to attend a single Sustainability Meeting. The President recounted after he attended on behalf of the F&C Officer that college staff initially confused him for Hector, as they have never actually met him. Whilst the F&C Officer has maintained that the meetings were scheduled too far in advance and occur during his lab times, he has made little effort to be proactive around them. Knowing when the meetings were going to take place a year in advance, the F&C Officer still failed to attend the one in 0th week of Hilary Term as he had not yet returned to Oxford. Despite knowing when the meeting would be months in advance, he chose not to attend potentially the only meeting he could go to that didn't occur during his lab times. Similarly, the F&C Officer has only attended 3 out of 5 RAG meetings during his tenure, further showing his disinterest towards environmental issues at college.

Last terms charity drinks were very well attended, with the profits amounting to some £400+. This money was donated to the Soil Society, as the E&C Officer very openly stated it was the

"Least Left Wing" environmental charity he could find. Whilst a significant sum was raised, it cannot be avoided that the decision of which charity the money should be donated to is problematic. Alongside this, the charity drinks were the only event that the E&C Officer ran last term, despite being mandated to run at least two. All other events were run by a different body.

Finally, the Environment and Charities Officer has consistently made clear his thoughts on the environmental aspect of role, which should constitute half of his role. When organising the Committee Fleece's for Freshers Week this past Michaelmas, the ex-Treasurer was asked by Hector to only have "Charities Officer" displayed on the fleece, not the full "Environment and Charities Officer" title; clearly, we can see his lack of enthusiasm towards the Environmental aspect of the role. During his Hustings, he made clear his opinion that he would only do the Charities aspect and not the Environment aspect, of his role. All these points demonstrate that the E&C Officer has maintained a level of disregard towards Environmental Issues within college.

#### Apathy towards the JCR committee

The F&C Officer has not only demonstrated his disregard towards environmental issues, but also his apathy towards the JCR and the JCR Committee, frequently avoiding responsibilities and thus requiring other Officers to perform his duties. Of the 9 JCR Committee meetings held during his term as the Environment and Charities Officer, he has only attended 4 – less than half. With 2 missed meetings a term without apologies constituting an automatic vote of No-Confidence, we must begin to doubt the E&C Officer's enthusiasm towards the JCR. Likewise, upon realising a motion of No-Confidence had been brought against him, the E&C Officer made it clear he would not be attending the meeting as he described it as "wet".

The E&C Officer has also demonstrated a level of disrespect towards other members of the JCR committee, who as a result of his apathy towards his role are forced to pick up the work that he does not do. The one sustainability committee that he could attend during 0th week of Hilary Term, the E&C Officer chose to not only not attend himself, but also left it last minute to find someone to attend for him. Having known months in advance the meeting would be held at that time, it was only the day before the meeting was set to occur that the E&C Officer asked the President and Vice-President if one of them could attend in his place. Here we can clearly see a lack of respect for other members of the Committee, who themselves are busy and should be informed well in advance, not the day before, if someone can't make a meeting. Further to this, last term when he could not make a meeting, the E&C Officer nominated the Vice-President to go in his place and to catch him up afterwards on what happened; all of this before even asking the Vice-President if they were available to go to this meeting, which they were not. His last minute and haphazard planning has frequently meant other members of the Committee have had to take up his work; his Charity drinks last Hilary being ran by the Beer Cellar Representative as the E&C Officer was at the Caledonian Society Ball instead. Last Trinity, despite frequent attempts to get the E&C Officer to plan his charity auction early during term to avoid clashing with prelims, the E&C Officer failed to do so, and as a result the event had to be merged with Pimms and Rounders, an event that had already been organised by the previous Clubs and Socs Officer. The President had asked the Domestic Officer to schedule one of the E&C Officers JCR Tea's early during the term, as he doubted his ability to do them on time - the result of frequent late JCR Tea's performed by the E&C Officer last term.

#### Lack of drive

All this combined demonstrates that the E&C Officer displays a high-level of disregard towards his role as both a representative of the JCR on environmental issues, and as a JCR Officer. He frequently fails to plan events, or to do so in good time, leading to clashes with other events or other members of the JCR having to do them for him. His attendance at both college and JCR meetings demonstrates clear apathy towards his responsibilities. Often citing work or being too

busy, the E&C Officer fails to recognise that all other members of Committee consistently manage to make it to the meetings, despite also being busy.

The Environment and Charities Officer clearly does not want to do the role and is regrettably holding onto a position which would be better suited for someone who cares about the Environment, the JCR, and doing a job they said they would do.

## **E&CO** Response

Hector: I think that the most sticky issue there is the narrative that I don't care at all and that I am skipping things willy nilly. And I do think that the mains are Sustainability committee meetings has fully been out of my control. The person who wrote the speech put it very well when they said that Hector did not return from Edinburgh for a one hour meeting. I am not, I am not going to. There is an inaccuracy in the idea that I knew the meeting in 0th week of Hilary this term a year in advance when I hadn't been elected a year before that. That is just total rubbish. I sent an email before the year had started like three days before the start of term to the secretary who scheduled the meetings to please don't ever schedule a meeting on a Monday or a Tuesday. I can't do it I have labs. Any chemist will know. They replied, oh you can probably reschedule labs. If you have got a two day lab, where you are using something on the second day which you made on the first, it is just not gonna work. And I am not gonna reschedule, you can't reschedule labs basically. The secretary who I emailed initially with this, all the emails I have got here, people can look at them if they don't believe me. The secretary no longer works here. The most telling thing is that there is a meeting on Tuesday in Trinity Term which I obviously can't make as well. And I send emails over and over again, can I read out an email which I sent upon realising that I couldn't make the meeting. After I was sent an email telling me to go to this meeting I sent: "dear Juliet, thanks very much for your email. I am very afraid that with the sustainability meeting sub-committee meetings continue to be at 11am on Tuesday, I will not be able to attend a single one! I have a lab scheduled every single week on a Monday and Tuesday at 11am to 5pm." - I realise that this is a slight inconsistency because I do have one or two weeks off but they haven't coincided with meetings. I don't understand how I am expected to go to a meeting which I have said I couldn't do far in advance. Before the year even started I am now being victimised for a meeting which I missed six months after the first time I said I couldn't do it. Then there is the Green Impact Meetings which I am said to have missed. I have been to, I think I have missed one, possibly two. Again because of a lab. They are also optional. I have been to, we have had six of them so far and I have been to five, possibly four. It is not like I just swan around not doing anything I think with no slight to the previous charity officer, I have actually done a lot of fundraising in comparison. I tossed up the stats I have raised about £800 for various charities. The argument about the Soil association is: a - I didn't say that it was the least left wing, I said that it was the least political charity, which I thought was true. When you have a large event, with lots of people coming, I don't think you should have people being discouraged on account of their political views differing from that to a charity which they are meant to be donating to. I think that the soil association genuinely has no politics, it simply cares about the environment and I thought that it was a pretty good cause to fund money towards it, the other charities have been pretty uncontroversial: comic relief - horrendous charity. WWF, which we raised a lot of money for last summer. And the idea that I didn't do the charity auction because I was asked to do it not during prelims and then I didn't. I coincided it with the pimm's and rounders so more people would come and more people would donate. I am struggling to remember the rest of those things as it was a long list of accusations but I do think that the main thing is that it portrays me as someone who doesn't care at all and hasn't been to any meetings and despite my best efforts I haven't be able to go to a few. But I do attend the vast majority. I do care. Why would I run these charity events, doing fundraising, if I didn't. also another accusation about not turning up to the Hilary Term charity drinks. I was asked to do it before a bop, I couldn't do the last four Fridays of the term and the Entz Committee said: Hector we really want you to do a charity drinks to coincide with a bop. And so I put it on a bop night but also said sorry I can't do it because I'm not around. I also wanted to do it in 7th week but they said you have to do it in  $5^{\circ}$  and I said sure but I can't come. I think it's all pretty, if someone who has a slight against me or I've personally aggrieved I am really sorry if I have. I don't think it's fair to say that I have such apathy towards everything. I would say that everyone on the committee I get along quite well with. The idea

that I treat everyone with total contempt is a bit of a joke I think. Maybe there is one person, I am really sorry if I have upset you but I think overall – I was quite surprised by the no con otherwise I was thinking that I was doing quite well in charity fundraisers and charity drinks. I think it is a but of a trumped up motion to be honest. Who wants to look at the emails which I've sent or had have sent to me then do let me know.

Debate:

Ed: There was a part about the RAG thing? I don't know much about that.

Hector: There weren't too many events happening last term, this term has been much more active. If everyone wants to check their inboxes, I've sent around emails before I was notified about the no con. It's all been forwarded.

Jacob: Just for the room, RAG means Raise and Give. It's an SU charity organisation

JJ: Just on JCR Teas. For anyone who doesn't know - it wasn't like this term where you have to do your JCR teas or else you get no-conned. Last term it wasn't that strict was it?

Michael: So, last term, the standing orders for JCR teas have only just been changed. Last term it wasn't formalised in that that would constitute a no-con. It was just more that the responsibility was to do it at 4 o'clock. To clarify the things about what I asked Nathaniel to do, I did ask Nathaniel to put one of your JCR teas in first week because you were consistently late last term and I did want to check if you were planning on doing it on time this term which you did this term.

Ed: This is more of a general suggestion regardless of whether or not Hector gets no-conned tonight or not. I think it might be worth considering the charities role and the environment role and how well they work together and whether it was actually a good idea to merge it last year because I don't necessarily think that someone who is passionate about charities has to be passionate about the environment. And I remember that when people were running for it last year, the joke in the hustings was basically that no one cares about the environment and everyone was running for the charities role? Which is like obviously you're running for both roles. But at the same time it kind of maybe it leads to the issue that two things shouldn't necessarily go together and it might be one of the more nonsensical things to have merged in the constitutional changes last year. Just something to considered.

Michael: Yeah, noted.

Tom: Sorry I should've said this in short factual questions but before submitting this motion, did exec have a meeting with Hector asking to improve his performance as environment and charities officer?

Michael: There was no formalised meeting

Jacob: There was a decision to have a meeting, which was made when Elias was President

Angelina: There was last term

Michael: Oh ok sorry

Elias: I wasn't there but there was in theory I think

Hector: Treya sent me a text about a meeting which she then didn't turn up to.

Jacob: Oh. In that case, that meeting apparently didn't happen.

Hector: She said come meet in the JCR at 4.30 for a chat about something I am yet to know about

Jacob: Our plan under Elias' presidency was for Treya to do that. Treya apparently didn't do that.

Tom: So this term has exec?

Michael: There has been no formal meeting however there was discussion—

Hector: There was no informal meeting either

Michael: There was—

Tom: Why did exec jump straight to a no-con rather than a meeting with the relevant officer?

Michael: At the beginning of the term, there was no formal meeting. However there were discussions with Hector and lots of joked being made at the beginning of term about a no-con being levied against him. And then there happened to be a no-con against him

Tom: So rather than meeting with him, you joked about no-conning him and then you just actually no-conned him?

Michael: To answer two of those questions, first of all, we joked about no-conning him - no we didn't. Other people have made jokes at Hector's expense that he is going to get no-conned for his performance based on his performance last term. Second thing, of the entire JCR, three of the people on this bench cannot submit a no-con: myself, Angelina, and Jacob. We do not have the energy or the will to get someone to submit a no-con against him. Oskari is far too busy—
