This JCR resolves to:

- Amend the Standing Orders of the President and Vice-President so as to remove "SU Student Council" from the respective lists of committees and to insert "Conference of Common Rooms" between "Computing Committee" and "Development Committee" in the respective lists of committees;
- Amend the Standing Orders of the Vice-President so as to replace Standing Order 13 with the following text: "To attend Conference of Common Rooms in the absence of the President":

RESCHEDULING JCR MEETINGS

This JCR notes that:

- Every year, there is a clash between Corpus Challenge and the JCR Meeting of sixth week of Hilary Term;
- This Trinity Term, there will be a clash between the Tortoise Fair and the JCR Meeting of sixth week of Trinity Term;
- The clash with Corpus Challenge was managed this year by having a number of Corpuscles sign a petition for an extraordinary JCR Meeting to occur on the Saturday, and by having the Returning Officer check that there was not a quorate JCR Meeting surreptitiously happening on the Sunday.

This ICR believes that:

- The yearly clash between Corpus Challenge and a JCR Meeting will continue to occur, and there could be a similarly repetitive clashes between the Ball and a JCR Meeting and between the Tortoise Fair and a JCR Meeting;
- Corpus Challenge, the Ball, and the Tortoise Fair are of a unique scale, rendering it impracticable to hold JCR Meetings on the same days as those events;
- However, the current solution is unduly onerous and confusing;
- This can be solved by allowing a JCR Meeting to occur on the Saturday prior to the JCR Meeting to avoid this sort of clashes, which would also prevent the Returning Officer from having to check that there is not a covert quorate JCR Meeting on these Sundays.

This JCR resolves to:

- Amend the Constitution so as to insert the following clause as Section 6, Clause XV: "XV. If the date of an ordinary JCR Meeting is scheduled to occur on the same day as the Ball, as Corpus Challenge, or as the Tortoise Fair, then that JCR Meeting shall occur on the Saturday immediately prior to the scheduled date. A rescheduling in this way shall have the following effects:

- A. This JCR Meeting shall be an ordinary JCR Meeting, so it will not fall within the rules of Section 7;
- B. The deadline for the submission of Motions for this JCR Meeting, with the exception of Motions of No-Confidence, shall remain Friday midnight, pursuant to Section 6, Clause III;
- C. The timing of the release of the agenda for this JCR Meeting shall remain Saturday midday, pursuant to Section 6, Clause IV; and
- D. It shall not be possible by any means to submit a Motion of No-Confidence to this JCR Meeting, notwithstanding Section 14, Clause I."
